Pre-test inspection: The sample is intact with no damage before test.

3.1.1. Test Procedure:

- 1) Sample number: 1#.
- 2) Drop the sample onto the floor from a height of 122 cm.
- 3) Drop surface: Steel plate
- 4) Drop orientation & quantity: 6 face, 12 edge, 8 corner, 26 drops in total.
- 5) After the test, the sample is inspected for appearance and functions.

3.1.2. Test Result:

After the test, the appearance of the sample has no obvious change, and all functions remain normal.

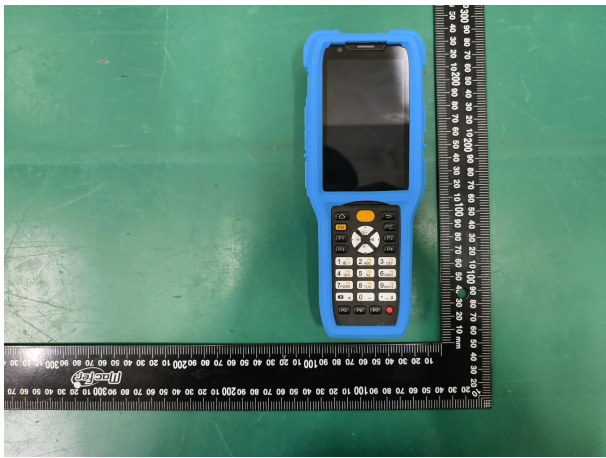

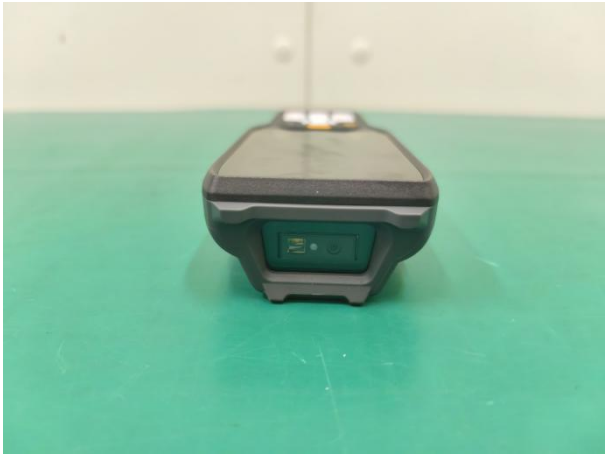
